

2007 NSCAA Board of Directors election proxy ballot

To the membership:

The National Soccer Coaches Association of America at present has 18 members on its Board of Directors. There are seven officers (president, three vice presidents, secretary, executive director and immediate past president) and eight constituent representatives serving membership from the youth (boys and girls), high schools (boys and girls), colleges (men and women), professional coaches (men and women) and three at-large positions. The election of members of the Board of Directors is held at the annual meeting of the members in conjunction with the annual convention.

This year's election involves two officer positions (third vice president and secretary), as well as the positions of College Men's Representative, High School Girls' Representative and Youth Boys' Representative. The Nominations Committee presents the candidates listed below for your consideration.

If you are NOT planning to attend the annual membership meeting to be held on Friday, Jan. 12, 2007, in Indianapolis, Ind., at the NSCAA Convention, you must complete this proxy ballot and return it to the national office by mail or facsimile machine in care of Jim Sheldon, Executive Director, or present it to him personally prior to the close of balloting in order to vote in this year's election. Complete instructions are included at the right.

The Election and Nomination Committee will inspect and count all proxy ballots prior to the annual meeting. The proxy ballots will be viewed with confidentiality and will be destroyed at the conclusion of the annual meeting.

- ◆ Ballot boxes will remain open at the annual convention until 5 p.m. on Thursday, Jan. 11, 2007.
